FPTR Qualifications & Rules

- 2019 Europe & Africa Future President's Team Retreat qualification requirements to be eligible to attend:
 - **Open to all President's Team and Millionaire Team,**
 - **PLUS Any Fully Qualified Supervisors who earn 2,500 R/O in each month for 3 consecutive months from December 2018 through October 2019 Volume Months (cheques paid January to November 2019)**
- Terms and Conditions apply. Please check the *Terms and Conditions* rules below.

Terms & Conditions

- Qualifications are based on the achievements of the individual Membership. Divorced Members with split IDs may combine 100% of the volume from the original (joint) ID, plus 100% of the volume on their "new" (individual) ID.
- All qualifiers must be in good standing with the Company.
